Dear Mr. Moore:

We are writing because there appears to be a date discrepancy in the registration material.

In the Year of Creation field of the application, you listed 2008 as the year of creation. However, some material in the work is dated 2015, which suggests new authorship was added to this work after the 2008 date.

The year 2008 may be the date you commenced with creation of the work submitted, but the Year of Creation field should contain the latest year that you added new copyrightable authorship to the work that has been submitted for registration.

Please let us know the year of completion for the version you uploaded, likely 2015, and authorize us to enter this year date into the record. If this material was published, let us know and provide the complete publication date (month, day, and year).

Furthermore, the application presents a claim in "text, computer program, artwork, A/V Media, photographs" however, because there are 212 files uploaded, it is difficult to locate all of these authorship elements. In the files viewed, there appears to be an abundance of preexisting material you compiled such as obituaries, copies of public records and certificates, images of website pages, and several photographs.

Please identify which files contain the material you created, specifically, tell us which file(s) contains your original text, your computer program source code, the artwork you created, photographs taken by you, and the audiovisual content you created.

Upon receipt of your response we will examine the content to determine copyrightability.

Please note that if we do not receive a response to this message within 20 days, we will close this case without processing your registration or notifying you further, and forward your deposit copy(ies) under the provisions of the current copyright law. The fee is not refundable. If you re-apply for registration after the case is closed, you must send a new application, copy and fee. The effective date of registration will be based on the new submission.

Ms. Robinson,

Yes the work started in 2008, but is ongoing, so for your purposes the latest date is appropriate. At the time I made the application, it was not clear how to best copyright a Family History Website. Unfortunately, I was not able to upload all of the content in the website (4,000 + files), due to servers timing out. The base software is copyrighted by the author, any modifications I've made to the software are what I reference as "computer program", these files have not been uploaded,

as the filenames will be of the type ".php". The compute program component is minimal, and may be deleted from my claim. The references to "text", "A/V Media", and "photographs" are meant to reference files included on the website that do not exist anywhere else, or if on the internet were copied from my work. The items that I reference as "text", "A/V Media", and "photographs" up uploaded to ".com" sites become include in those ".com" sites copyright. The question is how does an individual copyright a website as a ".net" (that is personal site, not a for-profit business)?

This week I will attempt to find better answers to your questions, but I think that I need to get a better understanding of how to copyright the contents of a Family History Website. Any assistance you can provide me will be much appreciated.

Thank you for your email.
